M., Umatilla County, Oregon; thence on a curve to the left 30 ft. from and parallel to a 3° curve and the central angle of which is 37° 30', 474 ft. thence N. 78° 04' E. 179 ft; thence N. 70 ft; thence S. 48° 04' W., 231 ft; thence on a curve to the right 30 ft. from and parallel to a 3° curve the central angle of which is 37° 30', 578 ft; thence E. 133 ft. to the place of beginning, containing, 1.01 acres of land more or less.
